# **Listed Company Information**

#### JMMB Group Limited (JMMBGL) - 10.11.2022

The Trinidad and Tobago Stock Exchange (TTSE) received notice from JMMBGL advising that Ms. Patria Kaye Aarons has tendered her voluntary resignation as a Director of JMMBGL, effective November 11, 2022. Ms. Aarons has taken the decision to resign based on her current professional commitments.

### Eppley Caribbean Property Fund Limited SCC - Value Fund (CPFV) - 09.11.2022

The TTSE received notice from CPFV advising that their Board of Directors will on November 18, 2022 consider a resolution for the payment of an interim dividend to stockholders.

#### Unilever Caribbean Limited (UCL) - 04.11.2022

The TTSE received notice advising that on October 28, 2022, the Directors approved the sale of the Company's property situated at Eastern Main Road, Champs Fleurs. The closing date for the sale of the property is December 15, 2022.

### ANSA McAL Limited (AMCL) and ANSA Merchant Bank Limited (AMBL) - 04.11.2022

The TTSE received notice from AMCL and AMBL advising that Trinidad and Tobago Insurance Limited ("TATIL"), a wholly owned subsidiary of AMBL, whose ultimate parent is AMCL, entered into a lock-up agreement dated November 25, 2021 with CL Financial Limited.

By letter dated October 28, 2022, the Central Bank of Trinidad and Tobago (CBTT) granted approval to AMCL / AMBL, to become a controlling shareholder of Colfire. The CBTT also issued to AMCL / AMBL a Controlling Shareholder Permit dated October 28, 2022. Accordingly, all regulatory approvals for the transaction have now been obtained.
