TTSE ONLINE TRADING PLATFORM (TOP) EXCEEDS EXPECTATIONS & TTCD ESTATEMENT PLATFORM UPGRADE

[PORT OF SPAIN, TRINIDAD] —The Trinidad and Tobago Stock Exchange Limited's (TTSE) online trading platform, TOP (TTSE Online Platform), continues to be widely embraced with 12,563 number of trades as at December 31st, 2022 representing an increase of 109% when compared to the same period of 2021. With a 52% increase from the prior year, TOP's year to date trade value was \$283.92 million as at December 31st, 2022 accentuating that our TOP trades continues to consistently account for over 25% of the market's total trades on a monthly basis for the period January to December, 2022. As we continue to revolutionize trading on the local and regional stock markets, the TTSE plans to implement upgrades to TOP to further enhance the user experience.

The Trinidad and Tobago Central Depository Limited (TTCD) eStatement platform which was introduced in August 2020, allows registered individuals and companies to generate their statements online. This platform which can be found on our website at https://ttcdestat.stockex.co.tt, would be re-engineered in 2023 to allow for on-line submission of transactions, enabling TTCD suite of services to be centralized in one portal. With this upgrade, the streamlining of transactional processes for stakeholders will allow for clients to enter requests via the eStatement platform that would automatically interface with the CSD system (Depend), resulting in improved efficiency and client experience.

How to invest with TOP

To create a TOP profile and begin trading, an investor must possess a Trinidad and Tobago Central Depository (TTCD) Broker Account, have a valid email address and assign funds to their online trading account. Investors can open a TTCD Broker account with any of the eight (8) Registered Stockbrokers. Investors with a TOP profile may access the platform from any electronic device, by logging on to https://top.stockex.co.tt. Investors may enter their orders 24 hours a day, 7 days a week. Users may view real-time movements in their portfolio and the stock market, and manage multiple trading accounts on the platform.
