Calypso Macro Index Fund (CALYP) - 15.03.2023

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from CALYP advising that the Board of Directors of the Bankers Association of Trinidad and Tobago (BATT) reappointed Ms. Sharmaine Caballero as a Director of the Board of the Trinidad and Tobago Unit Trust Corporation, for a further term of four years, with effect from June 25, 2023.

Calypso Macro Index Fund (CALYP) - 06.03.2023

The TTSE received notice from CALYP advising that further to the Material Change notification to the TTSEC on May 24, 2022, which advised that the Trinidad and Tobago Unit Trust Corporation (UTC) had entered into a Joint Venture Agreement with GraceKennedy Limited (GKC) in Jamaica to form a Joint Venture Company owned by UTC and GKC for the purpose of offering Mutual Funds in Jamaica.

On March 06, 2023, the GK Mutual Funds Limited will launch three Mutual Funds in the Jamaican market, two of which will be denominated in Jamaican Dollars and the third in US Dollars.

The UTC, through its subsidiary company the Unit Trust Corporation Financial and Investment Advisory Services Limited which is licensed as an Investment Adviser with the Financial Services Commission in Jamaica, will be providing Investment Advisory services for the three Mutual Funds. All the Funds will be subject to the regulatory oversight of the Financial Services Authority in Jamaica.

Agostini's Limited (AGL) - 03.03.2023

The TTSE received notice from AGL advising of the appointment of Dr. Wayne A.I. Frederick as a Director, effective March 01, 2023.
