First Citizens Group Financial Holdings Limited (FCGFH) - 13.04.2023

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from FCGFH advising that a Director purchased 200 FCGFH shares on April 12, 2023.

ANSA McAL Limited (AMCL) / ANSA Merchant Bank Limited (AMBL) - 13.04.2023

The TTSE received notice from AMCL and AMBL advising that the compulsory acquisition process initiated on March 10, 2023 by Trinidad and Tobago Insurance Limited (TATIL), a wholly-owned subsidiary of AMBL, whose ultimate parent is AMCL (AMCL owning 82.5% of AMBL's shares), pursuant to the provisions of Section 202 of the Companies Act, Chap 81:01 of the Laws of Trinidad and Tobago, to acquire the remaining 2.5% of Colonial Fire and General Insurance Company Limited (Colfire), representing the shareholding of the shareholders of Colfire who did not accept TATIL's offer and take-over bid to acquire all the issued and outstanding ordinary shares of Colfire, issued on December 29, 2022, was completed on April 06, 2023.

Guardian Holdings Limited (GHL) - 12.04.2023

The TTSE received notice from GHL advising that the Notice of Annual Meeting 2023, Proxy Form, Management Proxy Circular and Guidelines for Shareholders' Pre-Registration and Attendance at GHL's Annual Meeting 2023 have been issued to Shareholders, and are available for viewing or downloading. Additionally, they advised that their Annual Report is now available online for viewing or downloading.

FirstCaribbean International Bank Limited (FCI) - 11.04.2023

The TTSE received notice from FCI advising that The Eastern Caribbean Central Bank (ECCB) provided conditional approval for the sale of the assets and banking business of FirstCaribbean International Bank (Barbados) Limited (FCIB Barbados) branch in St. Kitts to the St. Kitts-Nevis-Anguilla National Bank Limited ('SKNANB') on July 15, 2022, subject to certain conditions.

SKNANB has informed FCIB Barbados that it has not secured final approval from the ECCB to conclude the acquisition. The ECCB has also notified FCIB Barbados of its decision to not grant final approval for the sale of FCIB Barbados' operations in St. Kitts.

Notwithstanding the denial of approval outlined above, the ECCB remains fully engaged with FCIB Barbados as it continues to assess its operational footprint in the Eastern Caribbean Currency Union.
