The proposed transaction is in keeping with NCBFG's ongoing startegy to recalibrate capital allocation.

They also advised that the completion of this transaction is subject to conditions including all necessary regulatory approvals. Following the proposed sale, NCBFG, through its subsidiaries, will provide transition support to Berkeley, in addition to maintaining its interest in NCB Capital Markets (Cayman) Ltd. and expects to record a gain in its consolidated financial results upon completion of the transaction. Further, NCBFG advised that going forward, the sale of NCB Cayman will not have a material impact on the future earnings or the asset base of the NCBFG.
