JMMB Group Limited (JMMBGL) - 22.02.2024

The Trinidad and Tobago Stock Exchange (TTSE) received notice from JMMBGL advising that the following JMMBGL ordinary shares were purchased on February 20, 2024, under their share buyback programme.

- 2,078 JMMBGL shares at JM\$27.48 on February 22, 2024
- 22,922 JMMBGL shares at JM\$27.50 on February 22, 2024

JMMBGL further advised as follows:

- 1. The purpose of the purchase was to bolster shareholder value over time.
- 2. The maximum intended repurchase is a total of JA\$300,000,000.
- 3. The source of funding was cash on their balance sheet.
- 4. The shares were repurchased on the open market via their broker, JMMB Securities Limited.

The TTSE also received notice advising that its Trinidad and Tobago financial entities (including JMMB Bank (T&T) Limited) are now indirectly controlled by JMMB Financial Holdings Limited which is the financial holding company of the JMMB Group licenced by the Bank of Jamaica as required under the Banking Services Act (2014).
