





- The top 3 most liquid securities as measured by DAVT, were MASSY, GKC and JMMBGL for the month of September 2024. GHL (83%), GKC (77%), SBTT (76%) and FCGFH (54%) monthly performance are notably above its respective 12-month moving average.

- RFHL took the lead with the largest number of transactions, recording 215 trades during the month of September 2024, followed by MASSY with 209 trades. SBTT reported 134 trades and FCGFH reported 124 trades for the same period.

- FCGFH, NEL, SBTT and RFHL traded on all 20 trading days while JMMBGL and MASSY traded on 19 out of the 20 trading days during the month of September 2024.


Across the First-Tier, Mutual Fund and SME markets, the cumulative number of trades in September 2024 was 1,363, a decrease of 393 trades or 22.38% compared to the trading activity in August 2024.

On a YOY basis, total trades recorded in September decreased by 323 or 19.16% compared to September 2023's trading activity.

On a QOQ basis, total trades in the third quarter of 2024 stood at 4,716, a decrease of 792 trades or 14.38% compared to the preceding quarter.

On average, there were 68 daily trades recorded in September 2024 (August 2024: 84 trades), in comparison with the daily average of 84 trades recorded during September 2023.



GKC reported the highest market turnover ratio of 0.74% followed by JMMBGL and NFM whose ratios stood at 0.29% and 0.23% respectively. Conversely, of all the securities traded, EHL reported the lowest market turnover ratio of 0.0009%.

On a YTD basis, UCL reported a market turnover ratio of 8.77%, followed by NEL and GKC, which reported turnover ratios of 4.69% and 3.86% respectively. Conversely, of all the securities traded, EHL and SOLIS recorded the lowest market turnover performances of 0.06% and 0.01%, respectively.
